(under section 21 & 22 of the RFCTLARR Act, 2013)

No. DC(IW)/6/29/LA/11(Vol-III): Whereas in connection with the project for construction of New BG Railway Line between Tupul to Imphal Section of Jiribam-Imphal Project, Phase-I and Phase-II, the Government of Manipur intends to take possession of the land, the particulars of which are given in the declaration under section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (hereinafter referred to the RFCTLARR Act, 2013) by way of notifications bearing no. 4/15/LA/2014-Com(Rev) and no. 4/15/LA/2014-Com(Rev)A respectively, both dated 8th September, 2015, which had been published in the Poknafam (Manipuri edition), the Sangai Express (Manipuri edition) and the Sangai Express (English edition) in their publications dated 09.09.2015; and

2. Whereas under section 21 of the RFCTLARR Act, 2013, all persons having interest in the land are required to appear personally or by agent or advocate before the Collector for making claims to compensations and rehabilitation and resettlement for all interests in such land; and

3. Whereas under section 22 (1) of the RFCTLARR Act, 2013, all persons are required to make or deliver a statement containing the name of every other person possessing any interest in the land or any part thereof as co-proprietor, sub-proprietor, mortgagee, tenant or otherwise, and of the nature of such interest, and of the rents and profits, if any, received or receivable on account thereof for three years next preceding the date of statement. Under section 21 (2) of the RFCTLARR Act, 2013, every person required to make or deliver a statement under this section shall be deemed to be legally bound to do so within the meaning of section 175 and 176 of the Indian Penal Code;

4. Now therefore, for the said purposes, public notice is hereby served under section 21(1) of the RFCTLARR Act, 2013, on all persons, having interest in the said land, to appear personally or by agent or advocate before the Collector, Imphal West in the Courtroom of the Deputy Commissioner, Imphal West at Lamphel as per schedule at para 7 below and to state, in writing and signed by the party or his agent, the following:

- (a) the nature of their respective interests in the land;
- (b) the amount and particulars of their claims to compensation for such interests;
- (c) their claims to rehabilitation and resettlement; and
- (d) their objections, if any, to the measurements made and marked on the respective lands;

5. Further, all persons notified through this public notice are also directed to make or deliver to the Collector, Imphal West as per the same schedule so fixed, a statement under section 22 (1) of the RFCTLARR Act, 2013 containing the following:

- (a) name of every other person possessing any interest in the land or any part thereof as co-proprietor, sub-proprietor, mortgagee, tenant or otherwise;
- (b) the nature of such interest;
- (c) the rents and profits, if any, received or receivable on account thereof for three years next preceding the date of statement.

6. This notice is also served, in connection with the lands mentioned in the declaration mentioned above, on the following persons who reside within Imphal West district or who have agents in this district authorised to receive service on their behalf:

- (a) the occupier of such land, and
- (b) all persons, known or believed to be interested therein, or
- (c) all persons, known or believed to be entitled to act for persons so interested.
